Supporting Notes:

- All members of the governing board and the head teacher/ principal and any others in attendance at the meeting must declare any interests and leave the room.
- The clerk to the governing board shall only be required to withdraw when the governing body is discussing the clerk's pay/contract or disciplinary action against the clerk.
- Governors have to withdraw when their own appointment, reappointment or removal as a member of the governing board or a committee is under consideration.
- Any governor who is employed to work at the school (other than the head teacher), must withdraw from a meeting where the pay or performance appraisal of any person employed to work at the school is under discussion.
- The head teacher must withdraw from any meeting where his/ her own pay or performance appraisal is under discussion.
- If a person has any pecuniary interest, direct or indirect in any contract, proposed contract or any other matter under discussion at a meeting he/she should at the meeting disclose the fact and withdraw from a meeting during the consideration or discussion and not vote on any question with respect to that matter.
- A person has an indirect pecuniary interest if he/she, or any nominee of his/hers, is a
 member of a company or other body with which a contract is under consideration or
 has been made; or if he/she is a partner in business, or in the employment of, a
 person with whom the contract is made or under consideration.
- A person has a direct or indirect pecuniary interest in a matter if a relative (including a spouse) living with him/her, has a direct or indirect pecuniary interest.
- The head teacher (whether a governor or not), a governor who is a teacher or member of the non-teaching staff, or any teacher who is in attendance in an advisory capacity should not have an interest that is greater than the interest of the generality of people employed at the school.
- A person present at a meeting of a selection panel at which the subject for consideration is that person's appointment (or that of his/her relative or spouse) to a post as a teacher or otherwise at the school, a transfer or promotion or retirement, or shall be a candidate for the resulting vacancy, he/she shall be deemed to have an interest.
